Partnership Revenue and Capital Budget 2024/25 - Update

1. Introduction

1.1 At its meeting on 15th March 2024, the Partnership approved a Revenue Budget for 2024/25 and Indicative Financial Plan for 2025/26 at <u>Item 2a Revenue</u> Budget and Indicative Financial Plan.

1.2 The report noted that:

"At the time of writing, there has been no confirmation of the Partnership's revenue grant for 2024/25 received from Transport Scotland.

"Financial planning remains based on no change in the revenue grant for 2024/25, with no re-distribution of grant among Regional Transport Partnerships (RTP's)."

1.3 It also noted that:

Transport Scotland was making significant changes to the Active Travel Behaviour Change and Access to Bikes programme, otherwise known as the People and Place Plan (PPP) and that, "subject to final approval by Transport Scotland's Authorised Officer, funding of £20m will be allocated to RTPs for 2024/25, of which £5.7m will be allocated to the Partnership.

"Pending further development of the Active Travel Behaviour Change and Access to Bikes project, the Core and Project budget proposals in this report do not include proposals in respect of the project.

"An update of the Projects budget will be reported to the Partnership, following confirmation of additional Scottish Government funding."

1.4 There have been developments in relation to both paragraphs 1.2 and 1.3, and this report presents an update.

2. Main Report

Transport Scotland Grant for 2024/25

The largest component part of the Partnership's funding is provided via a grant from Transport Scotland. The grant has remained static at £782,000 from 2011/12 to 2023/24. It has been estimated that this has resulted in a real terms reduction in funding of c.46% over that period (ref: figures provided by Nestrans to Transport Scotland in March 2024).

- 2.2 On 21st March, Transport Scotland contacted SEStran's Partnership Director and informed him that the grant would be reduced by 5% in 2024/25. This reduction is in line with savings required across most Directorates in the Scottish Government. On 26th March, written confirmation of the reduction and confirmation of the revised grant were received from Transport Scotland
- Given the timescale of notification, it is planned to manage the reduction in funding of £39,100 by use of the forecast Core budget carry forward from 2023/24. In the Finance Officer's report to the Partnership Board on 15th March, a Core budget underspend of £68,000 was forecast. The Partnership's Annual Accounts are currently being prepared for 2023/24. It is anticipated that the underspend will be at least £68,000. The unaudited Annual Accounts, including the 2023/24 underspend will be advised to the Partnership Board meeting on 21st June.
- Following discussions with Transport Scotland and Scotland's other Regional Transport Partnerships (RTPs), SEStran wrote to Transport Scotland and accepted the grant offer on 11th April.
- 2.5 The Partnership Director, along with the Lead Officers from the other RTPs, met with Transport Scotland to discuss this on 22nd April. The Leads have been asked to submit evidence to challenge the reduction, and Transport Scotland have undertaken to consider this and raise it with the Cabinet Secretary in the coming weeks.
- 2.6 At this stage, Transport Scotland are unable to clarify whether this is a one-year reduction to reflect the financial pressures currently facing the Government, or if it indicates a reduction in the Partnership's baseline budget.

People and Place Programme

- 2.7 On 15th March, it was reported to the Partnership Board that, for the People and Place Programme (PPP), funding of £20m would be allocated to RTPs for 2024/25, of which £5.7m would be allocated to SEStran.
- A verbal update provided to the Board at that meeting advised that funding had been reduced by 5%, and the total grant to RTPs would be £19m rather than the £20m stated in the report. The Board was also advised that SEStran's share would reduce from c.£5.7 to c.£5.3m.
- 2.9 On 16th April, SEStran received the formal Grant Offer from Transport Scotland £5,326,154.
- 2.10 The proposed allocation of funding of £5,326,154 for the People and Places Programme is detailed at Appendix 1.
- **2.11** Expenditure on the Partnership's Core and Projects budget, including the People and Places Programme, will be reported to the Partnership throughout 2024/25, in line with the existing financial monitoring arrangements.

3 Recommendation

- **3.1** It is recommended that the Partnership notes:
- **3.1.1** The reduction of £39,100 in Transport Scotland Core funding;
- That the reduction will be managed by use of the Core budget underspend for 2023/24;
- **3.1.3** That Transport Scotland has confirmed funding of £5,326,154 for the People and Place Programme.
- 3.2 It is recommended that the Partnership approves the proposed allocation of funding of £5,326,154 for the People and Places Programme, as detailed at Appendix 1.
